A595 GRIZEBECK

In the latest meeting held in Grizebeck Village Hall the County Council stated that they would take into account the concerns that numerous local residents have expressed regarding the proposed route. The present situation is that details are being sent to central government and once agreed the funding will be released for the project to begin in earnest. HOUSING DEVELOPMENT

The proposed new estate adjacent to the school has been set back somewhat due to a conflict between the developer and SLDC regarding the provision of the number of affordable houses to be built. Because of this the design and layout already agreed will have to change and revised plans will then be submitted.

The land adjacent to Beckside Rooms, Beckside, scheduled for three new houses, is to be sold by Holker Estates with planning permission.

LENGTHSMAN

Mr. Archie Workman is being employed by the Council to work in the Parish for some eight hours per month. He works also for Askam and Ireleth and Colton. You will recognise him by the jacket he will be wearing with "Kirkby Ireleth Parish Council" written on it. COMMUNITY CENTRE

The development at the Centre is well advanced and the first stage of the two new changing rooms is nearly completed.

The builders will cease work on completion of these and will return for the construction of the second and third stages in the Autumn.

LAKE DISTRICT NATIONAL PARK

The Council has arranged a Public Meeting to be held at the Community Centre on Wednesday 12th June This will make further information available as to the extension of the Park into Kirkby Ireleth. It will be a joint meeting with parishioners from Askam and Ireleth as there are plans to extend into that Parish as well. The presentation will be made by Mr. D. Savage the Chairman of Millom Without Parish Council

BBC COMMUNITY PROJECT

Belinda Artingstoll, a reporter and presenter working with BBC Cumbria, will be in the area during May gathering information and talking to individuals about the parish and its interests. This is the third such project carried out by the BBC recently the other two being in the north of the county. This is an opportunity to put Kirkby Ireleth on the map as much of the information she gathers will be used in broadcasts on Radio Cumbria. It is over thirty years since this type of reporting took place here. How much will have changed?

ELECTIONS

Elections for Parish Councillors will not take place on Thursday 2nd May as only the present Councillors put their names forward as candidates. OTHER MATTERS

- The speed monitoring vehicle has once again been active at Four Lane Ends and a number of drivers have been apprehended. Traffic measuring tubes have been placed at various places in Grizebeck to determine the amount and speed of the traffic on the A5902 and the A595

- Parking on grass verges and pavements, especially in Grizebeck where pedestrian access has been severely limited, is a continuing problem. The police have been informed and will be looking for offenders.
- The Annual Parish Meeting and the Annual General Meeting of the Parish Council will take place on Thursday 23rd May, 7.00 p.m. in Beckside Rooms.
Please note the change of date.
- A volunteer is still needed to cut the grass at Four Lane Ends. Please contact any Councillor if you would like to do this. You would join a group of like minded people in the Parish who work tirelessly to try to keep everything in good order. A volunteer has started in Grizebeck doing fine work clearing litter and tidying up where necessary.
- It is hoped to provide a litter bin at the “layby” near Muirlands.
- The new safety signs warning the public to take care when walking on the estuary will be put in place shortly.
- Holker Estates have given approval for a sand bag storage bin to be sited on their land on the road from Chapels to the caravan site subject to an official agreement being drawn up.
